## **EXECUTIVE BOARD**

### **President**

- Establishes the direction of the club and leads implementation
- Presides at all meetings
- Ensures financial solvency
- Fosters communication

### **Vice President**

- Arranges programs monthly for membership meetings by identifying topic and engaging speaker (September through May)
- Arranges venue and logistics for program presentation
- Provides back-up coverage to President

### **Secretary**

- Takes minutes of board meetings. Takes minutes at regular membership meetings when voting decisions are made.
- Maintains club email and Evite contact lists.

### **Treasurer**

- Receives and disburses all funds of the club in a timely manner to ensure financial solvency
- Maintains financial records and works with membership chair to maintain member database
- Oversees finances for club fund-raising events
- Reports monthly on financial status
- Publishes club year-end financial report

## **FULL YEAR COMMITTEE CHAIRS**

### **Communications**

- Lays out and publishes monthly newsletter
- Publishes annual directory from membership list provided by Treasurer
- Reviews website and recommends updates to the board annually
- Promotes publicity by furnishing articles on club activities to local papers (i.e., Mint Hill Times) and on social media (i.e., Facebook)

### **Corresponding Secretary**

- Sends “hugs” cards to members
- Sends Evites, email, and/or Perfect Pot Luck to members when needed

## **Membership**

- Coordinates membership drive if Board deems necessary

- Follows up with visitors and new members
